

- Ability to import/export files between JTIMS Lite and Enterprise

- Minor updates to adjust the amount and location of logging to enhance messaging.

v7.0 released 15 Jun 2011

- Provide User Group Leads/Event Team Leads/Event Managers the ability to override a SMEB Determination of "No" with supporting override comments.
- Provide a SMEX Executive Overview Report - generated in .ppt format.
- Reformat the SMEB Wizard so all "SMEB Exemption" questions appear on the first tab.
- Provide the ability to add, deactivate, edit, and reorder questions in each section of the SMEB Questionnaire.
- New SMEB Exemption report. This report provides a summary of events and the associated SMEB question(s) that make the event exempt from a SMEB.

- Provide Event Team Lead's the ability to notify the JS J7 SMEB Coordinators when the Event SMEB Executive Overview is posted to the attachments tab.
- Provide J7 System Administrators the ability to import legacy JMSEL v2.6 exercise data
- Add the "Recommended Source" column to the Manage Force Requirements list for a specific event.
- Require "Comments" from the force provider when force request is returned and not sourced and display FP comments when viewing the status of the Force Request.
- Add a new Event field to capture the benefits of conducting the event (on the Create Event page).
- Generate Force Tracking Numbers (FTNs) when the force request is "sent" to the Force Provider.
- Provide the ability for Force Requestors/Providers to mass edit Event Force Requests/Provider fields.
- Provide the ability to tag an exercise by CJCS Priority and Objective (new required fields are located on the Event Details tab).

- How well are we as the joint training community using JTIMS, our joint systems of record to document observations of training and to better inform our joint training/exercise/learning processes with our experiences and lessons learned?
- If joint organizations are not using JTIMS to manage their joint training programs, why not? Are software modifications needed?
- How should JS J7 address performance, technological and policy/standards issues to raise the level of JTIMS utilization?



Execution Phase Discussion



Issue: Do tools/systems (JTIMS/JLLIS) facilitate the application of lessons learned/exercise observations into future events during the exercise planning process; and the integration of issues into resolution processes?

Discussion

- How could we as a community raise the level of compliance in JTIMS utilization by a measurable amount?
- Who validates an observation as an issue to be resolved through a formal process? The CCMD J7? A contractor? An O-4/O-5 staff officer?
- What are the obstacles to implementing a standardized schedule for the observation vetting, resolution and elevation (from joint training program to joint lessons learned program) process?

Force Requirements

- Joint vs Service Events
 - Joint Events will display Joint Force Providers
 - Service Training Events will display the Service Force Providers (FORSCOM, ACC, FFC, MARFORCOM)
 - Only opportunity to select is during the “Create Event” process.
- Subordinate Force Requests
 - Allows components the ability to create an event and submit Force Requirements to higher headquarters (Combatant Command)
 - Minimizes the number of “duplicate” events
- New Requirements
 - Provide ability for Combatant Commands to “send” force requests to component organizations to conduct feasibility of support.



Joint Training Information Management System (JTIMS) Joint Master Scenario Event List (JMSEL)



Briefer: LTC Ray

- **Issue 10-012:** Transition from legacy JMSEL v2.6 to JTIMS JMSEL Enterprise.
- **Discussion:** Transition plan discussed during JTIMS UAG, WJTSC 10-2. Legacy JMSEL v2.6 data migration to JTIMS JMSEL (Enterprise); enhanced system availability and support; and costs associated with maintaining a separate JMSEL standalone environment. All commands and Combat Support Agencies agree that community needs to migrate to JTIMS JMSEL (Enterprise) but some expressed concerns that supporting organizations rely heavily on JMSEL v2.6.
- **Endstate:** Complete data migration from legacy JMSEL v2.6 to JTIMS JMSEL (Enterprise); JTIMS failover and backup capabilities deployed, tested and validated; JTIMS JMSEL application enhancements developed and deployed in FY11; and a timeline established, in coordination with commands/agencies, for shut down legacy JMSEL v2.6.
- **POA&M:** JS J-7 develop a timeline and plan to import legacy JMSEL v2.6 data into JTIMS JMSEL (Enterprise); complete hardware/architecture improvements, and complete deployment of JTIMS JMSEL application enhancements in FY12 . Jan 2012 conduct JTIMS JMSEL training with stakeholders.
- **OPR:** JS J-7 JETD; **OCRs:** Combatant Commands, CSAs, Services



JTIMS & Unclassified Defense Readiness Reporting System (DRRS) Integration



Briefer: LTC Ray

- **Issue 10-013:** Build METL capability requirement on NIPRNET.
- **Discussion:** DRRS NIPRNET shutdown approx. April 2010. JS J-7 discussed impacts with OSD Readiness Program Office: NORTHCOM requires capability for integration with NGB, JFHQ's, and DHS. JTIMS could incorporate the Build METL capability, however development timeline will be impacted along with additional costs. JTIMS Coalition environment dependent on a DRRS Build METL module to support command unclassified combined training events (PACOM, EUCOM).
- **Endstate:** Build METL module and Task Management capability deployed in a NIPRNET environment
- **POA&M:** OSD P&R deploy NIPR BuildMET /Task Management Module. JS J-7, in coordination with the commands, develop a timeline to reestablish Build METL/Task Management NIPRNET capability.
- **OPRs:** JS J-7 JETD and OSD; **OCRs:** Combatant Commands, CSAs, Services
